### Περιγραφή:

The village and natural areas of Alcaucín are among the most visited in the Axarquía (eastern Costa del Sol, Malaga). Its mild climate, its services, and its beautiful surroundings make it the best choice when choosing an area in which to live.

We propose an interesting property consisting of 2 houses: one with 3 bedrooms, and the other with two apartments with 2 bedrooms each. Located on a relatively flat plot of 7,593 m<sup>2</sup>, with public water, a legal well, and a water tank of 150,000 liters (approx.). The land is cultivated with olive trees.

Entering the fully fenced property, you will find the main house with 3 bedrooms (105.84 m<sup>2</sup>) with an open-plan kitchen with dining area, a living room, a bathroom with shower, and an additional kitchen. Outside, there is a large porch of about 80 m<sup>2</sup> (approx.), with a barbecue and oven. There is also a refreshing 8 x 4 m swimming pool.

In the second house there are two apartments, one of them with a porch with barbecue of about 50 m<sup>2</sup> (approx.). Both have an open-plan kitchen, living dining room, two bedrooms, and a bathroom with shower. The interior of one of the two apartments is not 100% finished (see photo). Some minor details



are needed.
