Barn to completely renovate (walls, gables, roof) of approximately 70m² on the ground on a plot of 865m², located on a pretty plateau in the Castelloubon valley, located at an altitude of 700m with a stunning view. Water drawn upstream from a communal plot serves the barn accessible by 4x4 over the last few meters (less than 200m).

The department of Hautes-Pyrenees is the southern-most department of the Midi Pyrenees region, its capital being the beautiful town of Tarbes.
